Definition of Terms:

Cardholder: Cardholder shall mean the individual whose name and signature appear on this application.

The Jacaranda Access Card does not constitute a membership at Jacaranda Golf Club. The Jacaranda Access Card is a separate program available ONLY to Florida Residents with a valid Florida Driver's License that allows the Cardholder access to the rates that appear on the reverse side of this form for the dates set forth on this application. The Cardholder will be entitled to ***5-day advanced tee times** at Jacaranda; however, those tee times are not guaranteed and will be offered on a first come, first serve, and space available basis. The Jacaranda Access Card is Non-Transferable and cannot be shared with another golfer. The Cardholder's Photo ID is required at check in. Jacaranda Access Card status will be forfeited and card will be confiscated if used by someone other than the designated Cardholder. The \$195 fee is Non-Refundable; however, Jacaranda Golf Club reserves the right to cancel a Cardholder's card for any reason or no reason by refunding the prorated unused portion of the \$195 fee. Lost cards will have to be replaced and will require a \$50 replacement fee. The Jacaranda Access Card will expire on November 15, 2021.

**One of the privileges of being a Master Member at Jacaranda is the ability to make tee times 7 days in advance. We understand that some of you are friends with Jacaranda Members and would like to play with them when you have the opportunity. We have taken this into consideration and created a Member Guest category specific to the Jacaranda Access Card from April 15, 2020-November 15, 2020 & April 15, 2021-November 15, 2021 which will allow you to play with a Jacaranda member on a weekend morning for a \$14.99 + tax surcharge in addition to the \$35 cart fee. This is still \$15 lower than our regular member guest rate during that time and will allow you to play on a tee time that was booked by a Jacaranda member.*

Golf Loyalty/Rewards points will be awarded on a pre-tax basis and 1 point will be earned for each pre-tax dollar spent on golf, merchandise, lessons and/or range balls. Each point is equal to a \$.05 reward (100 points = \$5 reward). Rewards may be used towards the future purchase of golf, merchandise, lessons and/or range balls and are NOT redeemable for cash. Golf Loyalty Rewards points cannot be earned on the redemption of gift certificates and points cannot be redeemed for gift certificates. Golf Loyalty Rewards points may not be earned on food & beverage purchases nor may they be redeemed for food and beverage items. Food & Beverage Loyalty/Rewards points will be awarded on a pre-tax basis and 1 point will be earned for each pre-tax dollar spent on food and beverage items and rewards earned may be used towards the future purchase of food and beverage items. Food and Beverage Loyalty Rewards points may not be earned on golf items nor may they be redeemed for golf items. The Golf Loyalty Program and Food and Beverage Loyalty Program are mutually exclusive. Each Jacaranda Access Cardholder is entitled to participate in both of these programs; however, a Jacaranda Access Cardholder may only earn rewards points on their golf rounds and purchases and not on the rounds and purchases of any other golfer or Jacaranda Access Cardholder. All Rewards from both Loyalty Programs will expire on November 15, 2021 and both programs are subject to cancellation at any time.

The Cardholder recognizes, acknowledges, and expressly assumes any and all risks associated with his/her presence on Jacaranda Golf Club property or facilities, including, but not limited to, the golf course, driving range, clubhouse, pro shop, and dining areas, and any and all risks associated with the rental or any other use of Jacaranda Golf Club property, including, but not limited to, golf carts and golf clubs. The Cardholder expressly acknowledges that participation in sports and/or recreational activities or presence on property intended for sports and/or recreational activities may subject the Cardholder to hazardous and/or dangerous conditions such as damages, injuries, or losses that the Cardholder may incur as a result of, among other things, lightning or other weather conditions, being struck by any foreign objects (including golf balls, golf clubs, sports equipment and the like) and the negligent operation of golf carts. The Cardholder hereby assumes the risk of personal injury and the loss of and/or damage to personal property and releases and agrees to indemnify and hold harmless Jacaranda Golf Club, Scratch Golf, LLC, its member(s), and their respective parents, subsidiaries, affiliates, related corporations, agents, officers, directors, and employees, from and against any and all losses and/or liabilities for claims, demands, suits, or causes of action in law or in equity for damages and injury, including death, of every kind and nature, whether to persons or property, arising out of or in any manner related to (i) the Cardholder's presence at Jacaranda Golf Club, and/or participation in sports and/or recreational activities at Jacaranda Golf Club, (ii) the Cardholder's rental or use of Jacaranda Golf Club property, (iii) the Cardholder's use of Jacaranda Golf Club services, including, but not limited to, golf club repairs, and golf instruction, and/or (iv) the presence of the Cardholder's personal property at Jacaranda Golf Club, regardless of negligence, provided the Cardholder shall not be responsible for damages and injury caused by the negligent or wrongful act of Jacaranda Golf Club.

The Cardholder further agrees to be responsible for damages to or loss of property of Jacaranda Golf Club, its members or guests caused by the Cardholder, and/or the presence of the Cardholder's personal property at Jacaranda Golf Club. Personal property of the Cardholder present at Jacaranda Golf Club shall be so at the owner's risk; Jacaranda Golf Club will not be responsible for lost, damaged, or stolen property.
